

Specifications and Scope of Supply for Pipe Support Assembly

Pipe assembly is required to support fuel pipeline of 1.5" diameter according to attached figures. Complete pipe assembly will be made of 4 mm thick GI pipes, straps/clamps, nut and bolts of high strength. Pipe assembly will have two sections as shown in attached Figure A and B, while complete assembly is shown in Figure C.

Section A:

This section consist two separate pipes (not attached with any means) of four feet long and 1.5 inch diameter, including top dead plug with threads to support hammering. Bottom of pipe will be welded with conical shape pointed section of 4 inch long, to ease advancement of pipe into soil. In this pipe nine numbers 12mm diameter holes are to be made from top 2" up to 30" with 3" c/c to facilitate insertion of 10mm diameter nut and bolts. These nut and bolts will help to hold Section B over Section A. Care should be taken to make holes in straight line on front and back surface of pipe.

Scope of supply:

• One set consists two 1.5" diameter GI pipe, 4mm thick, with nine numbers 12mm holes, 3" c/c from top 2" to 30", conical attachment of 4" long, two dead plug, attached at top------100 sets


Section B:

This section consist two numbers 2" diameter and 4 mm thick 2 feet long GI pipes. These pipes will be attached with pipe support saddle with anchor or detachable clamp of size 10"x2" of 6mm thick with holes and threads to tight upper strap with 10 mm bolt one inch long (no nut). Lower strap to be welded and fix on two 2" GI pipes. This section will be 10" apart from outer surface and 6" from inner surface. 12mm diameter three holes are to made 6 inch c/c from top 2". These holes will be made to facilitate insertion of 10mm diameter nut and bolts. After joining section A and Section B complete assembly will be tighten with four 10mm diameter nut and bolts as describes under Section A.

Scope of Supply:

- One set consists two 2" diameter GI pipe, 4mm thick, with three numbers 12mm holes, 9" c/c from top 2" to 30", detachable clamp of 10"x2" in which lower part to be welded with pipes and upper part will be detachable which can be fixed with two 10mm diameter bolts to hold 1.5 and 2" pipes (threads to be made accordingly)------100 sets
- 10mm diameter, one inch long bolts (two numbers)-----120 sets
- 10mm diameter nut and bolts 3" long (four numbers)------120 sets

After inspection if any section of assembly found defective, supplier/manufacture has to replace it within two days from date of supply without any financial implications.



TERMS AND CONDITIONS FOR SUBMISSION OF QUOTATION

- 1) The National Centre for Antarctic and Ocean Research (NCAOR) **invites sealed quotations** from the reputed firms for the **"SUPPLY OF GI 4MM THICK COMPLETE ASSEMBLY"** at NCAOR, GOA.
- 2) The tender should be submitted in sealed covers, super scribing **tender for "SUPPLY OF GI 4MM THICK COMPLETE ASSEMBLY"** sealed and addressed to the Director, National Centre for Antarctic and Ocean Research, Headland-Sada, Vasco-da-Gama, Goa-403 804. **Offer sent through fax will not be accepted.**
- 3) Overwriting and corrections should be attested properly. The bid should be complete in all respects and should be duly signed. **Incomplete and unsigned bids will not be considered at all.**
- 4) All relevant technical literature pertain to items quoted **with full specifications** (Drawing, if any), information about the products quoted, including brochures if any should accompany the quotation.
- 5) A list of **reputed clients** to whom the firm has supplied similar items to be furnished alongwith the quotation.
- 6) Quotation should be **valid for a period of 90 days** from the date of tender opening and the period of delivery required should also be clearly indicated. If the supplier fails to deliver the goods within the time to be agreed upon, for delayed deliveries and for delays in installation (wherever applicable) NCAOR reserves the right to **levy liquidated damages** at the rate of 0.5% per week or part their of upto maximum of 5%.
- 7) Please **specify the Make/Brand** and Name of the Manufacturer with address, country of origin and currency in which rates are quoted.
- 8) NCAOR is not entitled to issue form "**C/D**". No sales Tax or any other Tax shall be payable by us unless payment of the same is specifically mentioned by the suppliers in their bids and same is legally leviable.
- 9) NCAOR is **exempted from the payment of Excise Duty / Custom Duty** as per Govt. notification. Hence, the rates should be split into basic cost and Excise Duty if any.
- 10) **Bid should contain** all details and specifications, delivery schedule, payment term, user-list details of the price(s) of the item(s).
- 11) Please submit your quote on F.O.R. destination basis. In case of imported stores both **FOB and CIF prices upto Indian port of entry** namely <u>Goa</u> should be indicated. However tender should contain item-wise prices including total ex-works price and cost of packing forwarding, approx. cost of air-freight charges for delivery up to Goa, India.
- 12) The **warranty period** should be indicated.
- 13) A Committee constituted by the Director, NCAOR for the purpose reserves the right to open the bids. Bids will be opened on the date and time mentioned in the tender document in the presence of tenderer.

- 14) A technical Committee constituted by the Director will assess the product supplied/installed for their quality and their conformity to the specifications provided by the firm in their quotations. Any item(s) identified by the Committee to be not as per the specifications or are found to be of inferior quality will be rejected, and the bills towards the supply will not be processed for payment till proper replacements are provided.
- 15) **No advance payment** will be made. Payment for indigenous stores shall be made within 30 days from the date of receipt, acceptance of the material.
- 16) Two sets of operational, service/troubleshooting manuals and diagrams to be supplied with **SUPPLY OF GI 4MM THICK COMPLETE ASSEMBLY.**
- 17) **The submission of tender** shall be deemed to be an admission on the part of the tenderer, had fully acquainted with the specifications, drawings etc. and no claim other than what stated in the tender shall be paid in the event of award of Purchase Order.
- 18) **Acceptance of this tender** form and submission of the quote within the stipulated time would be treated as:
- a) The tenderer has understood all requirements as described in our Tender document.
- b) Acceptance to provide/establish all the facilities mentioned in our tender without any price escalation, if the tenderer finds it necessary to add any hardware or software or any other materials during implementation.
- c) Agreeing to execute order to the satisfaction of NCAOR or its authorized representatives within the stipulated time.
- 19) NCAOR will not be liable for any obligation until such time NCAOR has communicated to the successful bidder of its decision to release the Purchase Order.
- 20) NCAOR will not be responsible for any postal delays.
- 21) Bidders shall note that NCAOR will not entertain any correspondence or queries on the status of the offers received against this Tender Invitation.
- 22) Tenders from Manufacturers/Suppliers/Tenderers whose performance was not satisfactory in respect of quality of supplies and delivery schedules in any organizations, are liable for rejection. The tenders that do not comply with the above criteria and other terms & conditions are liable for rejection.
