Terms & Conditions

1. The bidder should be registered with Water Resources Department, Goa (Pl. attach copy of registration certificate)

2. The bidder should be located in or around Vasco Municipal area. (Pl. attach proof of address like telephone bill, Light bill etc.

Security Deposit : The successful bidder within one week of award of Work Order has to deposit Rs. 5000/- as a security deposit which will be returned after completion of the contract period.

3. The Contract period is initially for one year extendable on yearly basis for a further period of two years on the same Rates, Terms & Conditions of the tender/contract based on the satisfactory performance of the Contractor as assessed by NCPOR. Further to this also extension of the Contract is possible based on the mutual agreement of both the parties.

4. The water tankers are basically required to cater the need of drinking water of NCPOR. Water Tankers will have to be supplied on urgent basis on short notice, as and when required, within max. two hours of receiving the telephonic order.

5. The water tanker capacity should not be less than10 MT (10,000 ltrs)

6. The Contractor should provide cell phone numbers of himself & his drivers, supervisors. Water tankers are generally ordered from 8 AM to 6 PM. The contact phone numbers should be always switched on & connectable.

7. Tanker shall be filled & brought to the full capacity & emptied fully in the different tanks at NCPOR campus.

8. Acknowledgement of trips shall be duly signed & stamped by NCPOR Security. Original delivery challan should be handed over to the Estate section along with the bills.

9. Water should be potable and TDS (Total Dissolved Solid) value should be as per the standards. Test Certificate certifying the quality of water for potability to be produced from a reputed laboratory periodically to NCPOR.

10. Water Tankers should be Epoxy coated from inside & outside and size of the tanker to be displayed on the tanker clearly.

11. The Contractor should provide details of his water resources from where the water tankers are filled.

12. The rates quoted should be inclusive of water charges, transportation, labour, waiting and unloading time, taxes & all other things. No extra claims shall be entertained on the cost factor during any time odf the contract period.

13. All the mandatory water testing charges will be borne by the contractor.

14. Payment will be made monthly against submission of Monthly Bill in duplicate after satisfactory completion of monthly services after deduction of statutory taxes. No part payment/advance will be made. (As per the Govt. of India norms, payment to the Contractors are made online through Public Financial Management System (**PFMS**). The Contractor should submit his bank & other details in the prescribed format along with the first bill.) The contract is a fixed price contract & no escalation will be permissible during any stage of contract.

15. Penalty : Rs. 500/- penalty will be charged if the tanker is not supplier within 4 hours of the order by phone. Rs. 5000/- shall be charged if tanker is not supplied for consecutive 3 days. Security Deposit shall be forfeited if water is not supplied for consecutive 10 days. If the quality of water supplied is found to be contaminated or not as per drinking standards, payment for that tanker will not be made. If the same is repeated for three times in a month, the security deposit shall be forfeited, and the contract will be terminated.
