- 1) The firm should submit the attested copies of GST Registration/PAN/TAN No.
- 2) The Agency/ Distributors should not have been blacklisted by any Govt., Semi -Govt. Dept., or any other organization, an undertaking to this effect to be provided with the tender document.
- 3) Only manufactures for branded items can submit offers, if they are not in a position to quote, they may authorize only one exclusive agent of a particular brand. SECTION 4 – TERMS AND CONDITIONS.

- Quotations will be accepted only from manufacturers for branded items. If they are not in a
 position to quote, they may authorize only one exclusive agent, who may quote along with
 authorization. Authorized Agent quoting for the supply should attach valid authorization
 from the manufacturers to ensure prompt supply, failing which the quotation will be
 summarily rejected.
- 2) The Quotations should be submitted in sealed covers, super scribing supply of CHEMICALS, GLASSWARES AND LABWARES UNDER RATE CONTRACT, Tender No., due date & sealed and addressed to the Director, National Centre for Polar & Ocean Research, Headland-Sada, Vasco-da-Gama, Goa 403 804. Separate offers should be made for each Brand of Product i.e. Chemicals, Glasswares and Labwares. The offers will not be considered failing to submit separately for each brand of product against Chemicals, Glasswares and Labwares as mentioned in Section 2. Offers sent through fax/email will not be accepted.
- 3) Overwriting and corrections should be attested properly. The bid should be complete in all respects and should be duly signed. **Incomplete and unsigned bids will not be considered at all.**
- 4) **List of other organizations** where similar supplies have been made & having a rate contracts, documentary evidence may please be attached.
- 5) **The rate contract** can be terminated at any time by giving one month's notice from either side.
- 6) A Committee constituted by the Director, NCPOR for the purpose reserves the right to open the bids. Bids will be opened on the date and time mentioned in the tender document in the presence of tenderer.
- 7) **Price offered** shall be valid for a period up to 31.03.2023 and for **free delivery at NCPOR**, **Headland Sada**, **Vasco-da-Gama**, **Goa**. The manufacturer shall ensure that the products will not be sold cheaper than the price offered to NCPOR, to any other clients.
- 8) If the supplier fails to deliver the goods within the time to be agreed upon, for delayed deliveries, NCPOR reserves the right to **levy liquidated damages** at the rate of 0.5% per week or part their of up to maximum of 5%.
- 9) **Discounts** offered shall be indicated clearly in terms of percentage on the manufactures price lists.
- 10) **Special discount/prices**, if any, applicable to the Research Institutions aided by the Govt. of India should be quoted separately.
- 11) **Statutory increases** like levy, taxes duties etc. if any, during the period of contract, will be allowed extra on submission of documentary evidence.

- 12) Please mention the Catalogue No., Part No., and Model No. & Make wherever required and also GST No. and Area Code failing which your quotation will be rejected. All your future correspondences including Invoices should bear the GST No. and Area Code.
- 13) In case of Import, the Insurance & Freight Charges should not exceed 6% of FOB Value. You are requested to quote FOB price as well as CIF, GOA mentioning Freight & Insurance charges separately. **No Ex-Works pricing is considered.**
- 14) TRANSIT INSURANCE: The purchaser will not pay separately for transit insurance
- 15) Delivery Period for Import & Indigenous Items:

a. For Indigenous Items:

Items should be delivered within a week's time. No further extension of time will be allowed.

b. For Import Items:

The order acknowledgement should be issued by Fax or email within 3 days and the item should be airlifted within 15 days from the date of receipt of the Letter of Credit copy.

- 16) Non delivery of items will lead to cancellation of Purchase Order without any notice. In addition, action may be taken for removing them from Rate Contract.
- 17) **Replacement:** Damages / Broken / Inferior quality articles should be replaced by proper ones.
- 18) No Advance Payment will be made for Indigenous purchase. No part payment will be made. Payment will be made on completion of the full supply.
- 19) Our payment terms are normally within 30 days. However, all efforts will be made to effect the payment within 15 days after the supply is completed and accepted by NCPOR. For Imports, payment will be made by FDD / Wire Transfer after receipt of materials. 90% payment against documents can be agreed only in the case of necessity. The balance 10% will be paid after satisfactory supply.
- 20) NCPOR is not entitled to issue form "C/D". NCPOR is exempted from the payment of Custom Duty as per Govt. notification.
- 21) **CD of your catalogue/Price List** should be submitted along with 2 copies to NCPOR. If the latest pricelist is not available then pricelist presently available should be submitted which will be valid till publication/submission of new catalogues. Offers received without **catalogue/Price List** will not be considered.
- 22) Acceptance of this tender form and submission of the quote within the stipulated time would be treated as:
- a) The tenderer has understood all requirements as described in our Tender document.
