INSTRUCTIONS TO THE BIDDERS

1. The Director, NCPOR, Goa invites sealed tenders in one cover system, for the work of Renovation of RCC Over Head Tank & Other Ancillary Work at NCPOR, Goaø on turnkey basis, from the Contractors of Government/PSU/Reputed Organizations. The Eligibility Criteria is as below,

Eligibility Criteria: The bidder should have,

- (a) Executed at least one :single civil workø of Rs.30 lakhs or above OR two :single civil worksø of Rs.22 lakhs or above OR three :single civil worksø of Rs.15 lakhs or above of any Govt/PSU/reputed organization, company during last seven years ending March 2021. Civil work means Civil Construction work, Painting Work etc. related to this tendered work.
- (b) The bidding firm should have average Annual Financial Turnover of Rs.20 lakh per annum or above during last three financial years ending March 2021. (Pl. provide Audited Balance Sheet/Chartered Accountant Certified profit-loss statement.)
- (c) The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during last five consecutive balance sheet, duly audited or certified by a Chartered Accountant. (Pl. provide Audited Balance sheet/Chartered Accountant Certified profit-loss statement.)
- (d) GST Registration
- (e) PAN/TAN number
 - The bidder should fulfill all above eligibility criteria to become eligible for participating in this tender.
 - Self attested copies of all above documents should be enclosed. The original documents should be presented for verification as & when asked.
- 2. Time period for completion of work is 45days from the date of work order.
- 3. Any/firm/company which is black listed from any organization &/or facing/having faced any legal/criminal action/case are not eligible for this tender & should not apply.
- 4. The Earnest Money Deposit (EMD)/Bid Security: It is **Rs. 92,500/--** (Rs. Ninety Two Thousand Five Hundred only)in the form of a Demand Draft from any schedule bank, drawn in favour of **Director, NCPOR, payable at Vasco-Da-Gama, Goa.**
 - **Pl. Note**: Bidders need not to enclose EMD along with the bid document however, bidders should submit undertaking in the format provided at Annexure ó IX. Only the successful bidder will require to submit the EMD amount as detailed above. EMD of the successful bidder will be converted into Security Deposit.
- 5. Entire tender document (Signed and Stamped on all pages) should be submitted in a Single Sealed cover (Single BID System), super scribed with Tender number, name of the work, date and time of opening. Tenders will be received up to 11.00 am on 29.04.2021 and will be opened at 11.30 am on the same day. Tenders should be dropped in the tender box kept in the Estate section before the closing date and time indicated. If the tender opening day happens to be a holiday then tenders will be opened on the next working day on the same time. In case of submission of tender by post/courier, NCPOR is not responsible for any postal/transit delay. Late tenders will be rejected outright.
- 6. Tender submitted shall remain valid for 90 days from the date of opening for the purpose of acceptance and award of work. The extension of validity beyond 90 days from the date of opening

shall be by mutual consent.

- 7. It is mandatory to quote all items of the price bid. If all items are not quoted then tender will be considered as incomplete & will be rejected outright.
- 8. NCPOR does not bind to accept the lowest or any tender and reserves the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.
- 9. Re-writing, over-writing, use of correction fluid (whitener) is not allowed in the tender. The price bid should neatly handwritten/typed/printed & submitted in original with signature & stamp on all pages. Tender will be rejected if scanned copy or xerox copy is submitted.
- 10. The Tenderer shall quote rates both in figures and words against each item in English language only. Correction, cutting, omission, should be avoided. However even if any correction is made, it should be endorsed with signature. Use of correction fluid is not allowed & should be strictly avoided. On checking if there are differences noticed between the rates quoted by the tenderer in words and figures or in the amount worked out by him, the following procedure will be followed: (a). If there is a difference between the amount of, rate in figure and in words of an item, and the total amount is worked out, then the rate which corresponds to the amount worked by the bidder shall be taken as correct. (b) If the bidder has not worked out the amount of an item, or the same does not correspond with the rates written either in figures or in words, then the rate quoted by him in words shall be taken as correct. (c) If the rate quoted by the bidder in figures and in words tallies, but the amount is not worked out correctly, the rate quoted by the bidder shall be taken as correct and not the amount.
- 11. Before submission of tender, interested bidders should inspect the site to acquaint himself about the condition in regard to accessibility of site, nature and extent of ground, working condition of site and locality including stacking of materials, installations of tools and plants etc. required for the satisfactory execution of the work. Accordingly bidders should submit duly signed & stamped :Tender Submission Letterø (Annexure ó VIII) on their Firmøs/Companyøs Letter Head. No claim whatsoever on such account shall be entertained later by NCPOR under any circumstances.
- 12. Tenders with conditional prices / discounts will be rejected.
- 13. Successful bidder should commence the work within one week from the date of work order, failure of which the earnest money will be forfeited.
- 14. Except writing rates and amount, the tenderer should not write any conditions or make any changes, additions, alterations and modifications in the Price Schedule of tender.
- 15. Defects Liability Period (DLP): The DLP for the entire work is in two parts. The DLP for Painting & Waterproofing is Five Years from the date of completion of work as certified by NCPOR & for rest of the work it is Two Years from the date of completion of work as certified by NCPOR.
 - If any defect is found in the work during DLP, the Contractor has to rectify the same immediately at his own cost.
- 16. Security Deposit (SD): It is 10% amount of the final bill value. EMD of the successful bidder will be converted into SD. The balance SD will be deducted from the final bill amount of the Contractor. According to DLP, 5% of the total SD amount will be released after Two Years & balance 5% will be released after Five Years. SD is an interest free deposit which will be released only after successful completion of the Defect Liability Period.
- 17. In case of termination of contract, the Security Deposit shall be forfeited and amount necessary to make up this amount shall be recovered from the Contractor under this contract, or any other contracts with NCPOR.

- 18. Time is essence of the contract. The job must be completed within the stipulated time period, otherwise the contract is liable for penalty &/or termination as stipulated in the penalty clause.
- 19. A tender is liable for disqualification, if bidder is found to have mislead or furnished false information in the forms / statements / certificates submitted in proof of qualification requirements or record of performance such as abandoning execution of the works, litigation history &/ or financial failures and or suppression of material facts and information.
- 20. Director, NCPOR reserves the right to accept or reject any or all bids in full or part, or the right to not to accept lowest offer without assigning any reasons thereof, whatsoever. In case of any dispute, decision of Director, NCPOR shall be final and legally binding on the bidders.

Annexure-II

STANDARD TERMS AND CONDITIONS OF THE CONTRACT

1. INTERPRETATION:

- a. In construing these conditions the Specifications, the Schedule of Rates, additional Conditions and Agreement, the following words shall have the meanings herein assigned to them except where the subject or context otherwise requires.
- b. The contract shall comprise of the Articles of Agreement, General Conditions of Contract, Additional Conditions, Scope of Work, the Schedule of Rates, Specifications, Drawings, Work Order, Work Order Acceptance and other documents mentioned in the tender.

WORK OR WORKS: shall mean all work or works defined in Schedule of Rates. Specifications, Scope of Work and such other work or works as the Contractor may be entrusted with for carrying out under the contract.

EMPLOYER: shall mean the Director, NCPOR (National Centre for Polar & OceanResearch) or any Officer authorized by the Director for the purpose.

ENGINEER: shall mean the NCPOR Engineer designated by the Employer to superintend and performother duties as indicated in the contract.

CONTRACTOR: shall mean the individual or Firm or Company, whether incorporated or not, undertaking the work and shall include the legal personal representative or such individual or the persons composing such Firm or Company or the successors of such Firm or Company and the permitted assignees of such individual or Firm or Firms or Company.

SITE: shall mean the site of the contract works including any buildings and erections thereonand any other land adjoining thereto (inclusive) as aforesaid allotted by the Employer or the Engineer for the Contractor use.

2. CONTRACTOR TO PROVIDE EVERYTHING NECESSARY

- a. The Contractor shall provide at his own cost all materials, (except such materials, if any as may in accordance with the contract, be supplied by the Employer), Plants, tools, appliances, implements, ladders, scaffolding, temporary works etc. requisite for the proper execution of the work whether original, altered or substituted and whether included in the specifications or other documents forming part of the contract or which may be necessary for the purpose of satisfying or complying to the requirements of Engineer, as to any manner as to which under these conditions he is entitled to be satisfied together with carriage therefore to and from the work. The Contractor shall also supply without any extra cost the requisite number of persons with means and materials necessary for the purpose of setting out works and counting, weighing and assisting in the measurement or examination at any time and from time to time of the work or materials. Failing his so doing, the same may be provided by the Engineer at the expense of the Contractor and the expenses may be deducted from any money due to the Contractor under the contract and /or from his Security Deposit.
- b. The Contractor should personally supervise each work till completion or may appoint a qualified Supervisor, pre-approved by the Engineer till the completion of work.

No separate supervision charges will be paid.

- c. NCPOR shall provide requisite quantity of water, electricity for carrying out the work free of cost, subject to availability in the NCPOR campus.
- d. The Employer on no account shall be responsible for the expenses incurred by the Contractor for anything hired, which the Contractor needs to complete the ordered work.

3. DUTIES & TAXES

Rates quoted by the Contractor shall include excise and all duties, octroi, toll tax, levies, royalties and all other taxes in respect of this contract. Goods and Service Tax (GST) as applicable is to be stated specifically in the prescribed columns of the price bid. In absence of any such stipulation, it will be presumed that rates quoted are inclusive GST and no claim whatsoever in this respect will be entertained later.

4. MODE OF PAYMENT

Payment to the Contractor will be made within 30 days upon submission of bill in duplicate after satisfactory completion of the entire work as per the actual quantity executed after deduction of statutory taxes. No part payment / advance will be made. [As per the Govt. of India norms, payment to the Contractors are made online through Public Financial Management System (**PFMS**). The Contractor should submit his bank & other details in the prescribed format along with the bill.]

5. TESTING OF MATERIALS

The Contractor shall provide assistance, instruments, materials, labour and any other arrangement normally required for testing, checking of materials and workmanship as stipulated in the specifications and by statutory authority at his own cost. The Employer has the right to appoint the testing authorities. The Contractor shall pay for the cost of test samples, its packing, transportation including testing fees. Failing his so doing the same shall be provided by the Engineer at the expense of the Contractor and the expenses may be deducted from any money due to the Contractor under the contract and/or from the Security Deposit or proceeds thereof or of a sufficient portion thereof.

6. SAFETY & SECURITY: The Contractor should take utmost care while executing any such work performing at height & make proper adequate safety measures for his workers. Safety & Security of the Contractor manpower shall be sole responsibility of the Contractor. In case of any accident occurs due to any reasons during the work, NCPOR will not be responsible in any way for it. No extra compensation shall be made to the Contractor and No claim what so ever nature will be given or paid on this account and Contractor is fully responsible for such eventualities and he should indemnify NCPOR from such happening.

The Contractor shall provide all safety gadgets to his workers like Full Body Harness, Helmets, Shock resistant Hand Gloves, Safety shoes, Goggles, Masks etc.

7. CONTRACTOR'S ENGINEERS/FOREMAN & WORKMEN

- a. The Contractor shall give all necessary personal superintendence during the execution of the work and as long thereafter as the Engineer may consider necessary until the expiration of the Defects Liability Period. The Contractor shall employ qualified, experienced &competent Site-Engineer/Foreman. Any directions, explanations, instructions or notices given by the NCPOR Engineer to the Contractor Site-Engineer/Foreman or any other authorized person shall be held to be given to the Contractor.
- b. The Contractor shall on the intimation of the NCPOR Engineer immediately dismiss from the works any person employed thereon who may in the opinion of the Engineer be unsuitable or incompetent or behaved misconduct himself.

7. ACCESS

- a. The Engineer andthe Employer or its representative shall at all reasonable time have free access to the works and /or workshops, factories or other places the materials are being prepared or constructed for the contract work and also to any place where the materials are lying or from which they are being obtained and the Contractor shall give every facility to them for inspection. Except the representatives of the Employer or Statutory Authorities, no other person shall be allowed on the works at any time without permission of the Engineer.
- b. If any work is to be done at a place other than the site of works, Contractor shall obtain written permission of the Engineer.

8. VALUATION & PRICE FOR VARIATION

The Engineer with the approval of the Employer shall have power to make any alterations/omissions/additions and /or substitutions from the original specifications, drawings, designs and written instructions and such alterations, omissions, additions, substitutions shall not invalidate the contract and any altered, additional, or substituted work which the Contractor may be directed to do, in the manner specified above as part of the work shall be carried out by the Contractor on the same conditions in all respects on which he agreed to do the main work. The rates for such altered additional or substituted work under this clause shall beworked out in accordance with the following provisions in their respective order.

- a. If the rates for the altered, additional, or substituted work are specified in the contract for the work the Contractor is bound to carry out the altered additional, or substituted work at the same rates as are specified in the contract.
- b. If the rates for the altered, additional or substituted work are not specifically provided in the contract for the work the rates will be derived from the rates for a similar class of work as are specified in the contract for the work.
- c. Under no circumstances the Contractor shall suspend the work on the plea of non-settlement of rates of items falling under the clause.

9. FAULTY MATERIALS, WORKMANSHIP & DEFECTS AFTER COMPLETION

- a. The Engineer shall have powers to require the removal from the site of all materials and work, which in his opinion are not in accordance with specifications and in case of default, the Engineer shall be at liberty to employ other persons to remove the same without being answerable or accountable for any loss or damage that may happen or arise to such materials to be substituted thereof and in case of default the Engineer may cause the same to be supplied and all costs which may attend such removal and/or substitution are to be borne by the Contractor.
- b. If it shall appear to the Engineer or to the Estate In-charge that any work has been executed with unsound imperfect or unskilful workmanship or with materials of any inferior description or that any materials or articles provided by him for the execution of the work are unsound or of a quality inferior to that contracted for or otherwise not in accordance with the contract any defects, shrinkage or other faults which may appear within the defects liability period of Six months from the date of completion arising in the opinion of the Engineer, the Contractor shall on demand in writing which shall be made within six months of the completion of the work from the Engineer specifying the work, materials, articles defects or other faults complained of not withstanding that the same may have been passed, certified and paid for forthwith rectify or remove and reconstruct the work so specified in whole or in part as the case may require or as the case may be removed the materials or articles so specified and provide other proper and Suitable materials or articles at his own cost. In case of any such failure, the Engineer may rectify or remove or re-execute the work or remove and replace with others, the material or articles complained of as the case may be at the risk and cost in all respects of the Contractor.
- c. In lieu of rectifying the work not done in accordance with the contract, the Employer may, allow such work to remain, and in that case make allowance for the difference in value, together with such further reduction as in his opinion may be reasonable.
- d. Provided always that nothing in this clause shall relieve the Contractor from his liability to execute the works in all respects in accordance with the terms and conditions of this contract, or from his liability to make good all defects.

10. WORKS TO BE OPEN FOR INSPECTION

- a. All work under or in course of execution or executed in pursuance of the contract shall at all times be open to the inspection and supervision of the Engineer and the Contractor shall at all times during the usual working hours, and at all other times at which reasonable notice of the intention of the Engineer to visit the works shall have been given to the Contractor, either himself be present to receive order and instruction or have a responsible agent duly accredited in writing present for that purpose.
- b. The Contractor shall give not less than seven days notice in writing to the Engineer before covering up or otherwise placing beyond the reach of measurement any work in order that the same may be measured and correct dimensions thereof be taken before the same is so covered up or placed beyond the reach of measurement and shall not cover up and place beyond the reach of measurement, any work without the consent in writing of the Engineer and the Engineer shall within the aforesaid period of seven days inspect the work, and if any work shall be covered up or placed beyond the reach of measurement without such which the same was executed.

11. INDEMNIFYING AGAINST DAMAGES TO PERSONS, PROPERTY & STATUTES

The Contractor shall take all precautions to avoid all accidents by exhibiting necessary caution boards day and night, speed limit boards, red flags, red lights and providing barriers. He shall be responsible for all damages and accidents caused due to negligence on his part. No hindrance shall be caused to traffic during the execution of work.

a. The Contractor shall be responsible for all injury to persons, animals or things and for all

damage whether such injury or damage arises from carelessness or accident in any way connected therewith. This clause shall be held to include interalia any damage due to causes as aforesaid to work, building(whether immediately adjacent or otherwise) and to roads, streets, footh paths, bridges or ways as well as all damage caused to the buildings and works forming the subject of this contract by inclemency of weather. The Contractor indemnifies the Employer and holds him harmless in respect of all expenses arising from such injury or damages as aforesaid and also in respect of any award of compensation or damage consequent.

- b. The Contractor shall reinstate all damage of every sort mentioned in this clause so as to deliver the whole of the contracted works complete and perfect in every respect and so as to make good and otherwise satisfy all claims for damage as foresaid to the property of third Parties.
- c. The Contractor also indemnifies the Employer against all claim which may be made upon the Employer for acts during the currency of this contract by any employee or representative of an employee of the Contractor or any sub-Contractors, employed by him for any injury to or loss of life of such employees or for compensation payable under any law for the time being in force to any workmen or to the representative of any deceased or incapacitated workmen.
- d. The Employer shall be at liberty and is hereby empowered to deduct the amount of any damages compensation costs charges and /or expenses arising or occurring from or in respect of any such claim and/or damages as aforesaid from any sum or sums due or to become due to the Contractor or security deposit.
- e. The Contractor shall indemnify the Employer against any action claim or proceedings relating to infringement or use of any patent or design or any alleged patent or design rights and shall pay any royalties which may be payable in respect of any article or part thereof included in the contract. In the event of any claims made under or action brought against the Employer in respect of any such matters as aforesaid the Contractor shall be immediately notified thereof and the Contractor shall be at liberty at his own expense to settle any dispute or to conduct any litigation that may arise there from provided that the Contractor shall not be liable to

indemnify the Employer if the infringement of the : patent or design of any alleged patent or design right is the direct result of an order passed by the said Employer or his authorized representative .

12. IN CASE OF DEATH OF CONTRACTOR

Without prejudice to any of the rights or remedies under this contract, if the Contractor dies the Employer shall have the option of terminating the contract without any compensation to the Contractor.

13. COMPLIANCE TO LABOUR LAWS

The Contractor shall comply with all the provisions of the Minimum Wages Act, 1948. Contract Labour (Regulation and Abolition) Act, 1970 and rules and orders framed there under and other labour laws affecting contract labour and the rules and orders framed there under that may be in force or brought into force from time to time. NCPOR will not take any responsibilities towards any injury or compensation etc.

14. EXTENSION OF TIME

- a. If the Contractor shall desire an extension of time for the completion of the work on the grounds of his having been unavoidably hindered in its execution or any other ground, he shall apply in writing to the employer within seven days of the date of hindrance on account of which he desires extension as aforesaid and the Employer shall if in his opinion (which shall be final) reasonable grounds shown therefore authorize such extension of time if any which may in his opinion be necessary or proper.
- b. In the event the value of work exceeds the value of the Bill of Quantities owing to variations the Contractor shall be entitled to ask for extension of time in proportion to the increased value of work.
- 15. VALIDITY OF THE OFFERS: The offers will have to be kept valid for a period of 90 days from the date of opening of bids. In case of finalization of the tender is likely to be delayed, the tenderer will be asked to extend the same without change in the prices or any terms and conditions of the offer. If any change is made, original or during the extended validity period,

the offers will be liable for outright rejection without entering into further correspondence in this regard.

- **16. STATUTORY VARIATION:** Any statutory increase or decrease in the taxes and duties subsequent to suppliers offer if it takes place within the original contractual delivery date will be to the Employers account subject to the claim being supported by documentary evidence. However, if any decrease takes place after the contractual delivery date, the advantage will have to be passed on to the Employer.
- 17. REPEAT ORDERS: NCPOR reserves the right to issue repeat orders / additional orders to the Contractor up to 25% of the total value of the original Work Order at the same rate, terms and conditions up to One Year from the date of completion of the Original Work.
- **18. PENALTY &TERMINATION OF CONTRACT:** Time is the essence of the contract. If the Contractor fails to maintain the required rate of progress or to complete the work and clear the site on or before the completion date or extended date of completion, he shall without prejudice to any other right or remedy available under the law, pay compensation the amount calculated at the rates stipulated below or as the Employer may decide (whose decision in writing shall be final and binding) on the amount of the tendered value of the work for every completed day / week (as applicable) that the progress remains below or that the work remains incomplete.

In case, the work is delayed/not completed within the period stipulated in the contract, penalty shall be levied @ 0.5% per week of the total contract cost subject to maximum of 10% of the total contract cost. The Engineer may without prejudice to his any other rights or remedy against the Contractor in respect of any delay, inferior workmanship, any claims for damages and / or any other provisions of this contract or otherwise, and whether the state of completion has or has not elapsed, can take decision & inform the Contractor by notice in writing in any of the following cases.

- i. If the Contractor fails to rectify/replace the defects in spite of written notice by Engineer.
- ii. If the Contractor suspends the progress of work so that in the opinion of the Engineer he will be unable to secure completion of the work by the date of completion and do not improve performance even after written notice.
- iii. If the Contractor neglects to carry out his obligation under the contract and / or commits defaults in complying with any of the terms and conditions and does not remedy if even after written notice.

When the Contractor makes himself liable for action under any of the aforesaid cases, fails to complete the work even after six weeks after the completion period or in case the work is found not in accordance with the prescribed specification, drawings, Employer shall exercise its discretionary power either:

- a. To recover, from the Contractor as agreed by way of penalty clause above, OR
- b. To terminate the contract. Upon such termination, the full security deposit recoverable under the contract shall be forfeited/recovered and shall be absolutely at the disposal of the Employer, OR
- c. After giving notice to the Contractor to measure up the work done by him, get the balance work done by another Contractor. Any expenses which may be incurred in excess of the sum which would have been executed by the another Contractor, shall be borne and paid by the original Contractor and may be deducted from any of his dues.

Due consideration will be given for waiver / levy of penalty only for the reasons absolutely beyond Contractor¢s control for which documentary evidence will have to be provided. The request for extension of time in writing giving reasons for delay with supporting documents shall have to be made immediately.

19. POST TENDER CORRESPONDENCE / ENQUIRIES: Any correspondence or enquiry subsequent to opening of the bids is not desirable, if the same is indulged into, it will be considered for disqualifying the tender. The Tenderer will be required to abstain from pursuing / canvassing the matter, directly or indirectly with any Officers of NCPOR, as otherwise the same would also amount to disqualification of the tender. However, bidder can ask their queries in writing regarding bidding conditions, bidding process prior to the bid opening and/ or rejection

of its bid, reason for rejecting a tender after opening of bids.

- 20. CLARIFICATIONS FROM BIDDERS:To assist the process of examination, evaluation and comparison of bids, the Employer may ask all the bidders or any bidder individually for clarification, if any, of their bids, including breakdown of unit rates and price. The request for clarification and the response should be in writing, but no change in the price or substance of the bid will be sought, offered or permitted, except as required to confirm the correction of arithmetical errors discovered by the Employer in the course of scrutiny.
- **21. GUARANTEE:** If the goods, stores and equipments found defective due to bad design or workmanship the same should be repaired or replaced by you free of charge if reported within one year from the date of commissioning of items/equipments whichever. The Contractor will be responsible for the proper performance of the equipments / materials for the respective guarantee period.
- 22. SETTLEMENT OF DISPUTES/ARBITRATION: The decision of the Director, NCPOR shall be final and binding for any dispute whatsoever. All questions, disputes or differences whatsoever which may at any time arise between the parties to this tender contract touching the agreement or subject matter thereof, arising out of or in relation there to and whether as to construction or otherwise shall be referred to the decision of the Sole Arbitrator, appointed by the Director of NCPOR and the decision of the said Arbitrator shall be final and binding upon the parties.

SCOPE OF THE WORK

Brief Scope of Work: Over Head Tank (OHT), Under Ground Tank (UGT), other tanks & the entire water management system of NCPOR is almost 21-22 years old. The RCC OHT of 1 lakh ltr. capacity & located at the height of about 25 mts. UGT located below OHT is of the same capacity. UGT is filled by PWD water & water tankers every day & then water is pumped to OHT by 2 nos. of 10 HP motors by manual operation. Water then flows to all buildings by gravity.

The existing system is manual therefore it is planned to install fully automated water level monitoring & controlling system.

During the OHT, UGT renovation work the existing water management system will be disturbed. In order to avoid inconvenience to the functioning office, the Contractor needs to make some temporary modifications in the pipe lines, pumping system, create some temporary arrangements as instructed in Tender/ Work Order to keep water supply intact to office, labs, staff quarters etc. during the work.

Since there are no separate overhead tanks in the office washrooms, it is planned to install PVC Loft Tanks for each wash rooms, labs. The necessary plumbing & piping work is also included in the scope of work.

There is a metal stair case connecting UGT & OHT which needs to be renovated completely along with some other metal & fabrication work.

Once the renovation of OHT, UGT is completed, the temporary arrangements will be removed & the newly renovated water system will be made functional.

The detailed Scope of Work is as follows,

A. OHT repair work:

The repair of the OHT has to be completed within 15 days of duration which will include the following.

- Repairing and application of Water proofing treatments for OHT:
 Providing and laying integral cement based waterproofing treatment including preparation of surface as required, for treatment of RCC overhead water storage tank, consisting of following application.
 - a) Removal of existing loose damage concrete from structural members, Removal of rust from steel bars, scrubbing the surface with wire brush, cleaning with water.
 - b) Removing damaged/ rusted reinforcement and replacing same with suitable size & dia by lapping, welding or chemical anchoring etc.
 - c) Providing and applying rust inhabitator as per manufactures specification. Applying approved õRust Passivator / Inhabitator coatö over the treated reinforcement bars.
 - d) Providing and applying Bonding coat on exposed concrete surface with mixture of cement and polymer in ratio 1:1 and wire mesh (6mm x 6mm) of 22 gauge 200 mm wide over exposed surface so as to hold the micro concrete intact.
 - e) Providing injection grouting of polyrethane based injection resin, including drilling of bore holes.
 - f) Providing and applying bonding agent over the entire surface and finally plastering the internal surface of 18mm thick in cement mortar 1:3 with polymer admixture of specified brand / Readymade Acrylic based Polymer cement mortar as per manufacture specification and shall be applied in layers etc all complete with the given specification and as directed by Engineer In charge. Note: *The cost of scaffolding, Telescopic props, Shuttering, Centering etc. all upto required height, removal and disposal of rubbish to the dumping ground etc. included in above item.
- 2. The curing must be done for minimum period (8 Days).
- 3. Repairing and plastering of damaged surface of tank by using micro concrete, refill the cracks by crack filler and paint the entire external and internal (Pump room) surface of the tank by Acrylic water

proofing paint and Acrylic emulsion Paint for the steel structure (panel, staircase) and GI /CI pipe line by using Epoxy Paint as per s details specified in BOQ.

B. UGT repair work:

- 1. Repairing and application of Water proofing treatments for UGT:
 - Providing and laying integral cement based waterproofing treatment including preparation of surface as required, for treatment of RCC underground water storage tank, consisting of following application.
 - a) Removal of existing loose damage concrete from structural members, Removal of rust from steel bars, scrubbing the surface with wire brush, cleaning with water.
 - b) Removing damaged/ rusted reinforcement and replacing same with suitable size & dia by lapping, welding or chemical anchoring etc.

C. Plumbing work:

- 1. Cutting & merging of GI water supply line (4ö dia.) & downtake line (10ö dia.) by connecting customized flange.
- 2. Removing of existing GI & cast iron pipe by breaking First Floor concrete slab.
- 3. Installation of Loft tanks with necessary plumbing to be done at the respective sites mentined below:
 - a) Security cabin- 01 nos.
 - b) Washroom (Admin building) FF- 04 nos.
 - c) Washroom (Lab block building) FF- 02 nos.
 - d) Laboratory (Mezzanine Floor) ó 01 nos.
- 4. Platform for placing 10,000 liters water tank beside water meter chamber that will include excavation, rubble soling and P.C.C for creating a temporary base and necessary plumbing fittings to install the 10,000 liters water tank.
- 5. Excavation for 3ö dia supply line, chamber creation, installation of T ósection in the 3ö line & plumbing work to complete water supply to 10,000 liters tank.
- 6. Removal of bend & restoring existing system of GI 4¢ dia. supply line & 10¢ dia. downtake line in pump room.
- 7. Diverting suction inlet (4ö dia) & connecting the 10000 liters tank with GI pipe & NRV at suction system.
- 8. Restoring all modification to the original one except of new loft tank Installation.

D. Fabrication work:

1. Installation of M.S base frame to place the loft tanks work above the washrooms in Security cabin, Admin Building, Laboratory block. The base frame should be of L- shaped angle of size 40mmx40mmx3mm and flat strip of 3mm thick.

- 2. Installation of spiral metal staircase with mid pole of 8 inch dia of 8mm thick, thread checkered plate of 4mm thick, riser ó square rod of 10mm thick, base angle of size 40mmx40mmx5mm, railing of 2inch dia 2mm thick as per site and as directed by the Engineer ó in ó charge.
- 3. Installation of wall support extension ladder leading to the OHT of height: 16 x 28 with side support handle side support: c section 66mmx31mm, step section: 25mm non slip corrugated tube accessories: safety equipment for locking, nylon rope and rubber pads.
- 4. Fabrication and installation and of the central gate as per the existing design and as directed by Engineer ó in ó charge with MS tube sections of size detailed below:

E. Water tank Automation system:

- 1. The Level Detection system for main water tank will work as follows:

 Two nos of hydrostatic level transmitter shall be installed one in the OHT and the other in the UGT and the same shall be conneted to the controller for the planned functioning of the system. The hydrostatic type of Sensor will sense the level of water based on pressure exerted by water column and provide the continuous type of o/p. The controller unit which will be mounted in the panel at the pumping room will be set for HI and LO levels, as soon as these levels are reached, the relay o/p will switch on /off the motor contactor to regulate the pump motor. The controller color display will show at all times the level of water in the tank, the data from the controller can be remotely downloaded via LAN network on remote PC.
- Installation of Hydrostatic level transmitter should have an indication and control panel of bright LED coloured display with bar graph diagram, with remote access web server functionality. In suitable size MS powder coated panel.
- 3. The control panel will be installed in the pump room. The control panel should have a level controller with following specification:
 - Having minimum size 92mm x 92mm having a display of 3.5

 ØTFT colour display.
 - Secure data recording, dual programmer, high accuracy universal inputs, flash memory of 50Mb and above, having minimum 04 input options, Multi- language option support, web server connectivity, Alarm status and control loops.
 - Having a supply voltage of standard: 100 to 230V.
 - Input type dc Volts, dc mV, dc mA, dual mA, dual TC+.
 - Relay contacts witching power: Max. 2A at 230V.
 - Protocols: Modbus TCP/ IP master/ slave, Ethernet/ IP client/ server.
 - Termination: RJ45. Green LED illuminated = link connected, Amber LED flashing shows link activity.

F. Painting and miscellaneous work:

- 1. The loft tanks placed above the washrooms as mentioned earlier should be covered from the front and base part of the exposed tank with 12mm thick cement board and the same will have a coat of putty and 2 coats of washable emulsion paint, also a service door of 18mm thick marine plywood with necessary hinges, handles, magnetic catcher etc of size 0.9mx0.9m to be provided to access the loft tank for cleaning and maintenance.
- 2. The repair and painting of external surface of water tanks should include the following procedure:
 - Scaffolding around the water tank.
 - Removal of existing loose damage concrete from structural members, Removal of rust from steel bars, scrubbing the surface with wire brush, cleaning with water.

- Removing damaged/ rusted reinforcement and replacing same with suitable size & dia by lapping, welding or chemical anchoring etc.
- Filling the joints with rapid hardening mortar in addition with polymer synthetic rubber emulsion in 1:3 ratio with water, to fill the joints between concrete blocks and RC columns/beams. The treatment will include opening of joints by 1" X 1", cleaning it with water, application of bond coat, application of ready to use mortar by hand.
- Painting (Three or more coats on old work) with Waterproof Acrylic emulsion paint on external wall applying coat of primer of approved make, colour and shade to give an even finish, all as directed including all materials, labour, scaffoldings, brushes, tools, equipments etc., complete. Note: The above painting should be inclusive of base coat (primer cum waterproofing coat-two nos) and top coat (Paint coat-two nos). The paint should be a premium waterproofing paint with a definite warranty for waterproofing and anti-algal proofing.
- 3. The repair and painting of pump room should include the following procedure:
 - Removing white or colour wash by scrapping and sand papering on internal walls and
 preparing smooth surface by applying putty including necessary repairs the crack by filling
 approved crack filler to scratches and cracks etc. complete
 - Applying one coat of water based thinnable primer of approved brand and manufacture on internal walls surface.
