Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

1. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Eligibility criteria

(a) The bidder should be taxi contractor/individual owner having at least one vehicle of Sedan category registered as taxi (to be offered for service under the bid) in his name or bi dder's company/agency name. The vehicle make year should not be earlier than year 2020

.

(b) Following documents must be uploaded: -

- (i) Self-attested copy of valid RTO registration, vehicle permit and valid insuran ce and PUC documents in respect of the vehicle (Sedan) owned and offered by the Bidder.
- (ii) Self declaration that the firm/ individual bidder has not been blacklisted by any Central Government Department/Ministries/PSU's/Banks, etc. must be enclosed.
- (iii) Self-certified copy of the PAN card allotted to bidder shall be attached with the Bid/tender document.
- (iv) Self Certified copy of GST registration allotted to bidder/ self declaration, in case not registered under GST Act, must be uploaded.

2. Location of reporting:

The location for reporting of vehicle shall be NCPOR unless any other specific location provi ded by the buyer to the service provider in advance.

3. Penalty:

Penalties and Fines shall be applicable as per GeM Service Level Agreement.

4. Termination of Contract:

The Contract resulting from this tender may be terminated by NCPOR at any time during its currency as per GeM SLA terms or with two months notice without assigning any reason thereof or compensation in lieu, thereof. However, in case, if the contractor wants to cease the Contract, he s hall have to give three months notice to NCPOR.

5. Indemnity:

The tenderer shall indemnify NCPOR against any or all liabilities, legal, financial or otherwis e, which may arise during the currency of the Contract as a result of non-compliance with the afor esaid Terms and Conditions or otherwise.

6. Jurisdiction:

In the event of any dispute/ difference remains unresolved through NCPOR, the same shall be subject to the jurisdiction of the State of Goa.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
