1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which

no purchase preference shall be granted. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

3. Buyer Added Bid Specific ATC

- (1) The Bidder has to upload catalouge/brouchure of the offered product.
- (2) Detailed compliance on the bid technical specifications to be uploaded.
- (3) **Bidder Earnest Money Deposit (EMD)** As per GeM General Terms & conditions, scanned copy of EMD shall be uploaded by Seller in the online bid and original copy of the same will have to be submitted directly to the Buyer mentioned delivery address within 5 working days of bid opening, f ailing which the bid may be treated as incomplete & may lead to rejection of the bid by buyer without making any reference to the seller.
- (4) **Performance Bank Guarantee (PBG) -** As per GeM General Terms & c onditions, the Online PBG or Offline PBG must be submitted by Seller to t he Buyer within 15 days of award of contract on GeM. The payments to the seller shall become due only after receipt of Performance Bank Guarant ee by the Buyer and verification of its genuineness. No interest shall be p ayable upon the Performance Bank Guarantee.
- (5) If the Seller fails or neglects to observe or perform any of his obligations under the contract it shall be lawful for the Buyer to forfeit either in whole or in part, the Performance Bank Guarantee furnished by the Seller.
- (6) The Bidders to provide basic details sought in Buyer Added Specific ATC.
- (7) Break up of different price elements, i.e., as per GST Act, shall be indicat ed separately, along with its associated HSN code and GST rate. While qu oting the basic rate, the bidder should offset the input credit available/ to be availed as per the GST Act.
- (8) NCPOR is NOT liable to provide Form C or D or any other Form to claim G ST. However, NCPOR shall provide Customs Duty Exemption Certificate a s per the Govt. Notification 51/96. NCPOR will clear the consignment at G oa port and pay the applicable Customs Duty.
- (9) The amount of Agency Commission, (not exceeding the prescribed limit) payable to the Indian Agent should not be more than what is specified in the Agency agreement (a certified copy should be submitted along with the bid) between the bidder and the Indian Agent. The Indian Agent will be required to submit a certificate along with their Agency Commission bill, confirming that the amount claimed as Agency Commission in the bill has been spent/will be spent, strictly to render services to the foreign Principal, in terms of the Agency Agreement. The Purchaser or their authorized agencies and/or any other authority of the Government of India shall have rights to examine the books of the Indian Agent and defects or misrepre sentations in respect of the afore indicated confirmation coming to light during such examinations will make the foreign Principal (i.e. the Contract or) and their Indian Agent liable to be banned/suspended from having business dealings with the Purchaser, following laid down procedures for su

ch banning/suspension of business dealings.

- (10) **Undue profiteering:** Bidder shall specifically mention this fact in his bid givin g reasons for quoting a higher price(s). If he fails to do so or makes any misstateme nt, it shall be lawful for the Procuring Entity either to revise the price at any stage to bring it in conformity with the OEM prices or to terminate the contract and avail a ll the remedies available therein in addition to other punitive actions for violation of Code of Integrity.
- (11) **Book Examination Clause:** The Procuring Entity reserves the right for 'Book Examination' as follows: The Bidder/contractor shall, whenever call ed upon and required to produce or cause to be produced, for examinati on by any Government Officer duly authorised in that behalf, any cost or other book of account, voucher, receipt, letter, memorandum, paper or w riting or any copy of or extract from any such document. The Contractor shall also furnish information relating to the execution of this contract or relevant for verifying or ascertaining the cost of executing this contract t o such Government Officer in such manner as may be required. The deci sion of such Government Officer on the question of relevancy of any doc ument, information of return being final and binding on the parties. The obligation imposed by this clause is without prejudice to the contractor's obligations under any other statute, rules or orders which shall be concur rently binding on the contractor. The contractor shall, if the authorised G overnment Officer so requires (whether before or after the prices have b een finally fixed), afford facilities to the Government Officer concerned to visit the contractor's premises to examine the processes of production a nd estimate or ascertaining the cost of performance of Contract. The aut horised Government Officer shall have power, muted is mutandis, to exa mine all the relevant books of Contractor's subcontractor, or any subsidiary or allied firm or company, if any portion of the contract is entr usted or carried out by such entities. If on such examination, it is establis hed that the contracted price is more than the actual cost-plus reasonabl e margin of profit, the Procuring Entity shall have the right to reduce the price and determine the amount to a reasonable level. The Contractor or its agency is bound to allow examination of its books within 60 days from the date the notice is received by the contractor or its agencies calling fo r the production of documents. In the event of the contractor's or his age ncy's failure to do so, the contract price would be reduced and determin ed according to the best judgment of the Procuring Entity, which would b e final and binding on the contractor and his agencies.

12. Certificates

13. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

14. Warranty

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

15. Warranty

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 7 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG).Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imberse the cost of such service / rectification to the Buyer.
