- 4) Overwriting and corrections should be attested properly. The bid should be complete in all respects and should be duly signed. Incomplete and unsigned bids will not be considered at all.
- 5) **List of other organizations** where similar supplies have been made & having a rate contracts, documentary evidence may please be attached.
- 6) **The rate contract** can be terminated at any time by giving one month's notice from either side.
- 7) A Committee constituted by the Director, NCAOR for the purpose reserves the right to open the bids. Bids will be opened on the date and time mentioned in the tender document in the presence of tenderer.

- 8) Price offered shall be valid for a period up to 31.03.2014 and for free delivery at NCAOR, Headland Sada, Vasco-da-Gama, Goa. The manufacturer shall ensure that the products will not be sold cheaper than the price offered to NCAOR, to any other clients.
- 9) If the supplier fails to deliver the goods within the time to be agreed upon, for delayed deliveries, NCAOR reserves the right to **levy liquidated damages** at the rate of 0.5% per week or part their of up to maximum of 5%.
- **10) Discounts** offered shall be indicated clearly in terms of percentage on the manufactures price lists.
- 11) **Special discount/prices**, if any, applicable to the Research Institutions aided by the Govt. of India should be quoted separately.
- 12) **Statutory increases** like levy, taxes duties etc. if any, during the period of contract, will be allowed extra on submission of documentary evidence.
- 13) Please mention the Catalogue No., Part No., and Model No. & Make wherever required and also CST/VAT No and Area Code failing which your quotation will be rejected. All of your future correspondences including Invoices should bear the CST/VAT No. and Area Code.
- 14) In case of Import, the Insurance & Freight Charges should not exceed 6% of FOB Value. You are requested to quote FOB price as well as CIF, GOA mentioning Freight & Insurance charges separately. **No Ex-Works pricing is considered.**
- **15) TRANSIT INSURANCE**: The purchaser **will not pay separately** for transit insurance
- 16) Delivery Period for Import & Indigenous Items:

#### a. For Indigenous Items:

Items should be delivered within a week's time. No further extension of time will be allowed.

#### b. For Import Items:

The order acknowledgement should be issued by Fax within 3 days and the item should be airlifted within 15 days from the date of receipt of the Letter of Credit copy.

- 17) Non delivery of items will lead to cancellation of Purchase Order without any notice. In addition, action may be taken for removing them from Rate Contract.
- **18) Replacement:** Damages / Broken / Inferior quality articles should be replaced by proper ones.
- 19) No Advance Payment will be made for Indigenous purchase. No part payment will be made. Payment will be made on completion of the full supply.
- **20) Our payment terms** are normally within 30 days. However, all efforts will be made to effect the payment within 15 days after the supply is completed and accepted by NCAOR. For Imports, payment will be made by FDD / Wire Transfer after receipt of materials. 90% payment against documents can be agreed only in the case of necessity. The balance 10% will be paid after satisfactory supply.
- 21) NCAOR is not entitled to issue form "C/D". No Sales Tax or any other Tax shall be

- payable by us unless payment of the same is specifically mentioned by the suppliers in their bids and same is legally leviable.
- 22) NCAOR is exempted from the payment of Excise Duty / Custom Duty as per Govt. notification. Hence, the rate should be split into basic cost and Excise Duty if any.
- **23) DISTRIBUTORSHIP CERTIFICATE**: Sole selling Agents/Distributors of a particular make should submit a Certificate from their Principals to the effect that they are the authorized Agents of the Manufacturers and that they are authorized to import and supply to NCAOR.
